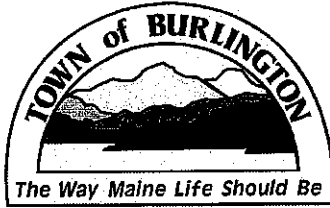

A motion was made and seconded to waive all penalties except 1/3 of the total amount imposed on the owners. There was a unanimous vote to accept this motion by all selectmen. <del>This will be the percentage used for future issues like this that may occur.</del> <b>AS</b></p> <p><b>C.</b> The Burlington selectmen, along with the Lowell selectmen, signed a policy on assisting property owners that have lost a dwelling to catastrophic fire damage. The Burlington/Lowell Transfer Station will offer a one-time donation of up to \$1,000 for Burlington and Lowell, full-time and seasonal, property owners who can provide prove that their own insurance company would not provide reimbursement or payment for the disposal costs of damaged materials as the direct result of a catastrophis fire-related incident .</p>
